

Product Name: **Midori-Mayu Silk BODY & HAIR Moist Shampoo**



This shampoo contains a high concentration of silk ingredients and can be used to wash the whole body. This enfolds the hair, face, and body with the luxurious moisture of Midori-Mayu Silk.

Main features:

- 1) Six free formulas that are gentle for adults with sensitive skin and children. (silicone, parabens, ethanol, synthetic fragrances, synthetic colorants, petroleum-based surfactants)
- 2) The fresh and sweet aroma of bergamot leads the body and mind to relaxation.

Directions:

When washing your body, lather an appropriate amount and use it, then lightly rinse off the foam. A distinct smooth and silky feeling will remain on your skin, but moisturizing ingredients will stay, so just gently pat dry with a towel.

For washing your hair, thoroughly wet both your hair and scalp, apply an appropriate amount to the entire hair, wash as if massaging, then rinse off until all foam is gone. Conditioning after shampooing is unnecessary, simply dry with a hairdryer.

This moisturizing lotion that contains high silk ingredients to the limit so that you can feel the moisturizing power of Midori-Mayu Silk directly. Since it is hypoallergenic, it can be used by adults with sensitive or fluctuating skin.

Main features:

- 1) The efficacy of this product in diminishing the appearance of dry wrinkles by its high moisture retention has been verified (the efficacy has been tested).
- 2) This has obtained 「COSMOS Natural」 certification, which is given to products using natural materials.

Directions:

- 1) Apply an appropriate amount (500-yen coin size) to your hand or a cotton pad and blend into clean skin after washing the face.
- 2) The moment the lotion blends into the skin, it may appear cloudy due to natural ingredients such as silk. This is a sign that the lotion is integrating with the skin and creating a silk veil.

Pressing it into the skin with hands will make it transparent.

SPF 17/PA+++ has been achieved using only silk ingredients without using UV absorbers or scatterers. Since this cut both UVA and UVB rays, daily skincare routine also serves as sun protection. Adults with sensitive skin can still care for daily UV exposure while moisturizing.

Main features:

Directions:

- 1) At the end of skincare routine, take 2 to 3 pumps (about the size of an almond) into hand and blend it over entire face.
- 2) The moment cream blends into the skin, it may appear slightly whitish, as if a veil has been applied to the skin. This is evidence of the silk component enveloping the skin. Pressing it into the skin with hands will make it transparent, leaving the skin feeling smooth and silky.

※ You can also use this for your nighttime skincare, no need to rinse this off.
